Available anywhere "old fashioned" lightbulbs are sold, ENERGY STAR® CFLs use 75% less energy and last ten times longer than standard incandescent bulbs. CFL energy savings are greatest in light fixtures that are used at least 15 minutes at a time or several hours a day.



Your municipal electric utility can recommend where and how to install CFLs. They also provide a convenient place to turn in old, spent CFLs for safe recycling.



### "Tame the Refrigerator Monster" and earn \$75!

When refrigerators, freezers and air conditioners are recycled, 98% of their materials are reused, and harmful refrigerants are removed in an environmentally-safe manner. 
Contact your municipal electric utility, who is equipped to remove them from your address and dispose of them properly.
