THE FOLLOWING INFO WAS NOTED (70 YEARS AGO)

ALSO 1943 ARMY SURPLUS
THE FIRE TRUCK - 1930 SANFORD - WAS HOUSED AT 9 E. BUFFALO ST., THE OLD VILLAGE HALL. THE FIREMEN OWNED A SQUAD CAR, WHICH WAS HOUSED IN A MEMBERS BARN. THE FIREMEN MET IN A ROOM ON THE 2ND FLOOR, THE ONE THEY HAD USED FROM THE TIME THAT BUILDING WAS ERECTED IN THE LATE 1800

THE COMPANY HAD BEEN LOOKING INTO INCORPORATION, AND EVEN HAD CLIFTON F.D. MEET W/ THE OFFICERS TO DISCUSS THE BENEFITS.

- AT THE MARCH 10, 1947, THE BODY VOTED UNANIMOUSLY TO INCORPORATE.

AT THAT TIME THE SOCIAL FUND BALANCE WAS \$2047.73, F.D. BALANCE OF \$20.59,
BINGO BALANCE OF ± \$800.00.

- AT THE APRIL 14, 1947 MEETING, THE INCORPORATION PROCESS WAS TO BE COMPLETED WITHIN THE WEEK - ^{34 members} SO IT WAS MOVED AND SECONDED TO HOLD THE ANNUAL MEETING IN MAY (THE NEXT MTG.)
